

Registration

Certain areas of the website (such as those where you can upload, post or share information), are only available to you if you register with us. The additional registration terms and conditions detailed in this document will apply to you if you choose to register with us.

Registration terms and conditions

These Registration Terms and Conditions are to be read in conjunction with our general Terms and Conditions and our Privacy Policy. These Registration Terms and Conditions apply to our discussion forums, blogs, induction and school club bookings system.

Definitions

A "Registered User" is a person who has registered to use a service on our website.

The "Registered Users' Areas" are areas of the website that require registration before a person can gain access, for example the booking systems.

"Your Content" is any and all the content submitted or uploaded by Registered Users, including names, addresses, images, photographs, video clips, payment information, text, logos, marks and any other information and materials.

Registration process

Before you are able to access Registered Users' Areas you must read through these Registration Terms and Conditions. To register you need to provide a verifiable email address, phone number, postal address and password on the registration form and read and accept these Registration Terms and Conditions. Once you have done this, we will send you an activation and confirmation email with your registration information.

Eligibility

By registering with the website you warrant that: all registration information you submit is truthful and accurate; you will maintain the accuracy of this information; your use of areas of the site for registered users does not violate any applicable law or regulation.

Passwords

By registering, you promise to keep your password secret and not to disclose or share it with anyone. If you believe that someone else may have access to or know your password you must change your password in the My profile section of the website.

Email addresses

To register with the website, you will require a valid email address to create a user profile. Once a user profile has been created, a different email address cannot be associated with it. If you wish to change your email address, you will need to register again with the website, using your different email address.

You agree that before posting or uploading your content you are responsible for obtaining all releases, consents and/or licenses necessary for uploading your content on our website and for any subsequent use of that content by us in accordance with these Registration Terms and Conditions.

You promise that you are the person depicted in any images or recordings submitted as part of your content and if you upload any images or recordings of any third party, you have obtained the prior written consent of that party to submit such content to our website.

Content standards

You agree whenever you submit your content to our website or contact other registered users you must comply with our content standards. If you do not comply we reserve the right to suspend or ban you from using the website and the Registered User Areas without notice.

Use of your content

We reserve the right to reject, block, suspend, or remove your content at any time at our sole discretion and without contacting you about it. We reserve the right to make minor amendments to your content, to bring it in line with our terms and conditions. Your personal information
